A WORD FROM THE MANAGING DIRECTOR



The last Member Directory was a special anniversary edition, since we celebrated 70 years of existence in 2023, and luckily, we have achievements and milestones to celebrate also this year.

We are living well up to our goals and expectations, not only the KPIs, however, as all companies and organizations, we must be alert to always bring value to our customers/members. We all knew about the VUCA environment, and recently at an event with the HR Committee we learned about *permacrises*, a word that won a prize recently. The Business Climate Survey will grow in 2025 and more than 40 countries will participate. As a board member of SCI Swedish Chambers International it is a privilege to be in the forefront when it comes to the internationalization of the Swedish Chambers abroad, and also the regional Chambers in Sweden.

We are steadily growing on social media and I really hope you already follow us on LinkedIn, YouTube and Instagram. Our media partner EVCOM is doing a great job in creating noise about our activities out there in the giant cyber space. The sky is no longer the limit for what and who we can reach.

Electrolux Group approaches 100 Years in Brazil Focused on innovation, sustainability and consumer experience

The development of products with unique design and high performance, strong investments in operations and people, and the constant pursuit of excellence in the consumer journey are factors that define Electrolux as a strategically global brand for the Group. These are also the reasons that solidified the brand as the top seller of home appliances in Brazil*, as well as the most recalled brand by Brazilians** in 2023. All this happens just two years before reaching a century of activity in Brazil, which will be in 2026.

With four factories in Brazil, the Group is preparing to inaugurate a fifth unit. In the first half of this year, it began construction of a manufacturing plant in São José dos Pinhais, in the state of Paraná, with investments exceeding U\$128 million. This will be the Group's first 100% sustainable facility in the region and will generate approximately two thousand direct and indirect jobs. Meanwhile, the Group continues to invest in strengthening its portfolio, which is the largest in the sector in Latin America, totaling over 1,000 products.

Recently, it reinforced its leadership in the multidoor refrigerator category with Auto-

Sense technology, which uses artificial intelligence to automatically control temperature and prevent food waste. Among the innovations, there is the most compact multidoor refrigerator in the national market, demonstrating the brand's vision of keeping up to the needs of those living in smaller apartments and wish to pursue a premium standard. This, combined with market leadership since 2020 in A++/A+++ refrigerators, considered the most efficient in the market. The brand's goal is to democratize sustainable technologies while innovating into new consumption habits and lifestyles.

At Electrolux Group, our mission is to shape living for the better by offering solutions that truly make a difference in everyday life. We know this is only possible because we constantly innovate. Each product, each factory or service is designed to create value for both people and the planet," emphasizes Leandro Jasiocha, CEO of Electrolux Group Latin America.

The event featured valuable insights from both academia and business, with engaging speakers from Insper and Atlas Copco. The night concluded with lively networking, laughter, and new connections made among the participants.

Looking ahead to October, we're excited to invite all YP members to a social Happy Hour. Think of it as what we in Sweden call "AW" (After Work), where we gather to relax, enjoy a drink, and catch up after a busy day. It's the perfect opportunity to network and unwind in a laid-back setting.

On November 7th, we will host the 10th edition of the Sweden-Brazil Career Fair at Transamerica International Plaza in São Paulo. We're preparing to welcome a large number of Brazilian students eager to explore opportunities for studying in Sweden or working at a Swedish company here in Brazil. Several prominent companies, including Volvo Cars, Saab, Nexer, Epiroc, Essity, Ferring, and AFRY, have already confirmed their participation. In addition, leading Swedish universities from across the country will be represented. SWEDISH BUSINESS CLIMATE SURVEY -

In June we launched the 2024 version of the Brazil Business Climate Survey (BCS). The BCS is part of a larger global assessment with the goal to evaluate the business environment in 23 key markets for Swedish companies. A global analysis of the surveyed markets was presented in Stockholm on June 14th, providing an outlook of the world's business climate and overall conditions for Swedish expansion worldwide.

This year, 54 Swedish companies with local operations in Brazil participated in the survey, which represents the highest engagement in the series of the BCS. Below, the main takeaways:

- **1.** 83% of Swedish companies in Brazil were profitable in 2023, maintaining the high level seen in previous years
- 2. 79% of companies expect to grow their business, and 59% confirmed new local investments
- **3**. 39% perceive Brazil's business climate as positive, 57% as regular and only 2 companies (4%) perceive it negative
- **4**. Taxes, regulation and infrastructure continue to represent the main challenges to do and run business in Brazil
- **5**. 3-4 companies were exposed to some form of corruption in 2023; one company identified human rights violations
- 6. Environmental awareness and the green transition are growing as important topics in Brazil

> SWEDCHAM REPRESENTATIVES

After a year of market uncertainties and a new government elected, the majority of Swedish companies still see the market as neither very positive nor too negative. However, only 4% have a stronger negative position about Brazil, which represents the lowest observation in the series, marking an overall more optimistic outlook. In fact, 39% see the business climate as positive, the third highest figure in the series since initiated in 2016. 79% of respondents indicated that they expect to grow in Brazil in the next 12 months, a relevant increase over the 2023 assessment, while only 4% expect to see a reduction in revenue. However, a lower share of companies (59%) expects to invest in Brazil during the same period. This may represent the idea that, although companies expect to grow and be profitable in Brazil, their global organizations are facing challenges in other markets, preventing larger local investments.

When it comes to sustainability, 58% of the respondents said that the environmental impact will be driving change in Brazilian business in the next years. Moreover, the companies' assessment over their customers environmental concerns has changed since 2020. Now, 39% indicate that their customers consider environmental aspects during their purchases, against 23% four years ago. This year, only 22% said that customer concerns over the environment are little or very little, a low record figure for the BCS. Yet in another question, 46% of companies see that opportunities related to a green transition can be created depending on stronger government action, while 43% already identify great business related to segments such renewables, energy efficiency and mobility. Despite the cost sensitivity challenges in the Brazilian market, preventing local customers from acquiring cleaner but more expensive solutions, the green transition is already a hot topic for Swedish companies and their positioning in Brazil.

The fact that more companies than ever before participated in the survey indicates that the management teams see the report as a useful tool and temperature gauge for business in Brazil. Since the survey became global, it has added yet another unique dimension where we can compare results and investments among many markets, and being able to do so annually is extremally valuable considering how fast the business landscape is changing.

APPLIED ESG HANDBOOK – A GUIDE FOR RESPONSIBLE SOURCING

Swedcham's ESG Committee has been working to share information among companies, helping to implement production processes and business practices that meet important agendas: environmental sustainability, social responsibility and ethics in governance. One of the topics the Committee has been focusing on is responsible sourcing. Responsible sourcing covers sustainable procurement, transparency in business relations, supplier training, redesign of natural resource extraction and consumption, among many other topics covered in this Handbook. The subject is broad and the following pages certainly do not address all of its aspects. But they bring enough information to show that these issues will redefine various value chains in the coming years. Cases are part of Swedish multinational companies, mainly industries, but they can surely inspire other businesses, regardless of size or industry. Recommendations can be adapted in different industries and locations. The invitation is made for organizations to considerably reduce negative impacts and encourage positive and sustainable aspects throughout their supply chains.

Postpartum haemorrhage (PPH) is one of the leading causes of maternal mortality and severe morbidity. Approximately 60% of severe bleeding cases are caused by uterine atony. 1.2.3 This condition is among the primary causes of maternal mortality in Brazil, which remains high at 107.5 deaths per 100,000 live births. According to the Ministry of Health, there was a 77% increase in cases between 2019 and 2021.4

Postpartum haemorrhage is defined as any bleeding exceeding 500 ml in vaginal births and more than 1 litre in caesarean sections within the first 24 hours after delivery. Factors such as inadequate antenatal care and obstetric complications can contribute to the maternal mortality rates in Brazil. A maternal death is defined as any death during or up to 42 hours after childbirth due to haemorrhage or other causes.5

"The figures show that maternal mortality and postpartum haemorrhage are a significant public health issue in Brazil, requiring special and targeted attention," says Rafael Suarez, CEO of Ferring in Brazil.

According to the risk classification, postpartum haemorrhage is more likely to occur in cases of multiple pregnancies, pre-eclampsia, chorioamnionitis, episiotomy, caesarean section, macrosomia, use of vacuum extraction or forceps, and a history of postpartum haemorrhage. When these conditions are identified during antenatal care, women can receive preventive therapy for postpartum haemorrhage. 1,2,3

Although there are known risk factors that increase the risk of PPH, this type of haemorrhage can also affect women who did not present these factors. 1.2.3 "That is why an individualised assessment of each case is important, to be carried out through dialogue between the woman and her doctor during antenatal care, to evaluate the use of preventive therapy even without risk factors," comments Sérgio Teixeira, Medical Director of Ferring in Brazil.

Prevention of mortality from postpartum haemorrhage is crucial and can be achieved through the use of medications that stimulate uterine contractions. When these contractions are insufficient, the risk of bleeding increases, endangering the woman's life.6 Prevention is a feasible and accessible reality nowadays.
