The Swedish Chambers' Young Professionals (YP) network continues to serve as a dynamic platform connecting Swedish and Brazilian professionals and students who share common interests and ambitions. With more than 200 active members, YP fosters both professional and personal development by promoting knowledge exchange, career opportunities, and cultural integration, while also assisting newly arrived Swedes in adapting to Brazil.

The year 2025 began with an **enriching Corporate Visit to Electrolux Group**, one of our long-standing partners and a global reference in innovation. Participants were introduced to the company's trajectory in Brazil, with particular emphasis on its practices in diversity, sustainability, marketing, and organizational culture. The program concluded with a practical challenge in which participants developed marketing strategies for real products, stimulating creativity, collaboration, and applied learning.

In May, YP partnered with the **Sweden Alumni Network Brazil** to host a special event at *Horta das Flores* in São Paulo. The initiative brought together members, alumni, friends, and families for a guided tour, an informative session on PANCs (Unconventional Food Plants), and a collective planting activity, leaving a symbolic and lasting contribution to the space while strengthening community ties.


Later that month, YP and the Alumni Network held a convivial **Happy Hour & Pizza Night**, offering a valuable opportunity for members to reconnect, expand their networks, and engage in informal exchanges in a relaxed setting.

Looking ahead, YP will continue to organize initiatives that combine professional development with cultural and social interaction. The highlight of the calendar will once again be the **Sweden-Brazil Career Fair in November 2025**, which this year celebrates its 12th edition. For the first time, the fair

will feature a **dedicated "Work in Sweden" area**, designed to provide practical guidance, resources, and inspiration for those interested in pursuing professional opportunities in Sweden, in collaboration with the **Swedish Institute**. This addition further strengthens the event's role as a comprehensive bridge between Brazilian talent and Swedish institutions.

As we move forward, YP reaffirms its commitment to providing high-quality experiences that contribute to the growth and success of its members, strengthening the ties between Sweden and Brazil.





SWEDISH BUSINESS CLIMATE SURVEY

In May 2025, we launched the new edition of the Brazil Business Climate Survey, part of the global initiative led by Business Sweden and the Swedish Chambers International. This sixth edition gathered responses from 48 Swedish companies of different sizes and sectors, confirming once again the strong presence of Swedish business in Brazil, where companies have been established for over a century and today employ around 50,000 people. Conducted between February and March, the survey is aligned with the broader Global Business Climate Survey, which this year expanded to cover 37 markets worldwide and was presented in Stockholm as a comparative outlook for Swedish companies considering international expansion.

The results for Brazil show a market of cautious optimism. Swedish companies continue to perform strongly, with most expecting revenue growth but fewer planning new investments, reflecting both local economic conditions and global uncertainties. The survey highlighted the following key findings:

- 81% of Swedish companies in Brazil were profitable in 2024, while only 11% registered losses
- 69% expect to grow their revenues in the next twelve months, but just 45% plan to increase local investments the lowest level since 2020
- 57% perceive Brazil's business climate as regular, 30% as positive and 13% as negative
- Inflation, exchange rate volatility and new tariff measures from the United States were cited as major concerns for the short term
- Trade barriers decreased compared to 2024, but customs duties and local content requirements remain the most relevant challenges
- 29% of companies confirmed that investments in sustainability helped boost their sales, while nearly half see opportunities in renewables, efficiency and mobility solutions

Overall, the 2025 edition paints a picture of resilience combined with caution. Profitability remains high and growth expectations are robust, but investment intentions have weakened amid economic and geopolitical uncertainties. At the same time, companies stress that cost-efficiency and adapting products and services to local needs are key to maintaining competitiveness. Despite the challenges, the Swedish footprint in Brazil — grounded in sustainability, innovation and a long-term commitment — continues to provide solid ground for future expansion

HUMAN RIGHTS AND LABOR: A SUPPLIER AWARENESS GUIDE

Building on the ESG Handbook on responsible sourcing released in 2024, Swedcham is proud to introduce a new guide focused on raising supplier awareness and promoting respect for human rights. Developed in collaboration with leading Swedish multinational companies — AAK, ABB, Alfa Laval, Atlas Copco, Assa Abloy, Autoliv, Epiroc, Electrolux, Höganäs, Tetra Pak, Scania, and SKF — this material underscores the vital role of businesses in advancing fair and dignified working conditions across supply chains.

These companies, with a strong presence in Brazil, have long been committed to monitoring, improving, and influencing labor practices in line with internationally recognized human rights standards. Their efforts show that responsible business conduct goes beyond compliance — it is about leadership, transparency, and fostering a culture of respect throughout the value chain.

While legislation, regulations, and codes of conduct are essential for setting expectations and requiring ethical behavior, true impact is achieved when compliance is paired with awareness. Rules alone are not enough. A deeper understanding of human rights principles allows companies to move from simply "not doing harm" to actively "doing better" — creating safer, more equitable workplaces.



This year's guide was developed by members of the Swedish-Brazilian Chamber of Commerce, with the support of the Swedish Embassy in Brazil. Its goal is to promote a culture of respect for human rights in the corporate environment, especially among suppliers. By recognizing the human aspect of business, we pave the way for better working conditions, stronger communities, improved productivity, and a reduction in social inequality.



Electrolux Group Unveils Its Largest Expansion in Latin America with a 100% Sustainable Factory

As it approaches a century of operations in Brazil, Electrolux Group has taken a bold step toward the future with the inauguration of its most ambitious industrial project in Latin America. Located in the city of São José dos Pinhais, State of Paraná, the new factory represents a R\$700 million investment and is the company's first fully sustainable plant in the region.

Designed to align with Group's global goal of achieving carbon neutrality by 2033, the facility operates entirely on renewable electric energy and uses only electric vehicles and equipment. It also incorporates advanced water-saving technologies, natural lighting, and a zero-landfill policy from day one.

Beyond its environmental impact, the plant is a catalyst for local development. It is expected to generate up to 2,000 direct and indirect jobs and foster innovation through the local production of blenders - products previously imported - and fans, for the first time produced worldwide, meaning a new product category to the brand's portfolio. With a projected annual output of over 5 million units by 2027, the site will account for 25% of Electrolux's small appliance revenue in Brazil.

"This factory is a symbol of our commitment to sustainable growth and innovation in Brazil," said Leandro Jasiocha, CEO of Electrolux Group Latin America. "It's not just about producing appliances—it's about creating a better future for people and the planet"
